

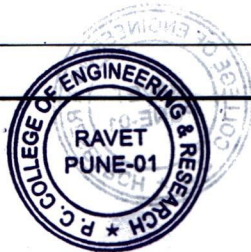

1. To Confirm the Minutes of last meeting held on 8<sup>th</sup> January 2021-

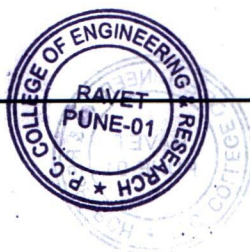

2. Review of First and Direct Second Year Admission 2020-21-

Principal put the admission details of First and direct second year Engineering. He told that the admission count is increasing every year and College has acquired good position in Pune University. He told that Branding and admission cell had given contribution for good numbers of admissions and due to teamwork College had fulfil all these admissions.

Admission in charge Asst.Prof.Manisha Deshpande explained cut off of all streams from 2014. She proudly shared that cut off of College is continuously increasing and also explained reason behind the same. She told that faculty had given tremendous efforts for counseling students in admission process.

3. Review of NBA visit preparation-

NBA coordinator Asst.Prof.Shweta Koparde put forth the NBA activity calendar. She told about various activities carried out in College till date and also talked about upcoming activities in view of NBA visit. Principal explained the department wise SAR marks and also put forth the expected dates of NBA visit.

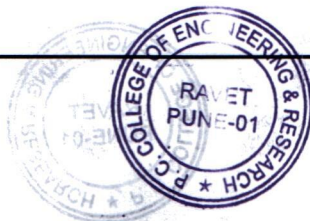
Hon. Secretary Shri.V.S.Kalbhor inquired about the external mock visit. Principal explained that it was scheduled on 27<sup>th</sup> and 28<sup>th</sup> March 2021. Dr.G.M.Desai asked about the mode (online/ offline) in which the NBA visit will take place. Principal told that considering the present pandemic situation the visit may be carried in online mode. Further he told that in coming weeks it would be clear.

4. Review of Academics, T&P, Research & other development activities.

All HODs put forth the revised result analysis of all years and also explained the improved results which were remarkable. Principal told all committee members that second semester was started online mode and covered almost 40-50 % syllabus. He further told that First Year also started online through Google meet. He told that we had planned to conduct crash course and also schedule Unit test online. The HODs told that most of the academic activities are going on as it is only the mode of delivery is online.

Dean III Mr.ShitalkumarRawandale put forth the placement data of last year as well as current academic year. He told that 80.97% students of 2019-20 batch were placed with average package of 3.69 LPA. He further told that 53.52% students were placed in IT Product or Core Companies. He further told that placement of 2020-2021 batches is going on and 131 students were placed till date.

Hon. Vice chairperson smt.Padmatai Bhosale asked about the extra efforts to increase average salary and placement. Executive director Dr.G.M.Desai insists to focus on placement in Product development companies (core companies). He also suggested to start add on courses to fill up the gap between Industry and Institute. Principal told about the initiative related to Honors course under SPPU. Principal further told about the various activities of staff and student development. The committee appreciated all HODs efforts for all activities related to Academic, T&P, R&D and staff and student development especially during the pandemic.





5. Review of CIPCIS.

Principal put forth the high lights of second unique conference on IPR, Copyrights, Innovations and startups 2020. He further told that there was overwhelming response for the online conference CIPCIS 2020 and it became a bench mark of PCCOER. He told that we focused on commercialization of IPR in CICIS which was very important in this era.

6. Policy revision regarding -

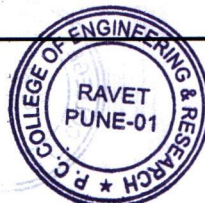
I. Financial support to needy and deserving students –
