Time: 03:30 pm in online mode.

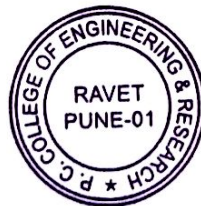

Meeting of all members of the Grievance Redressal Committee was held on 18/02/2021 Time: 11:00 am in online mode.

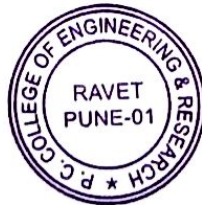


Following points were discussed in the meeting as per the agenda:
