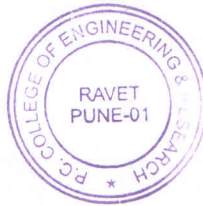

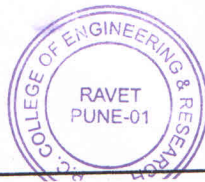

❖ Minutes of Governing Body meeting No. 12

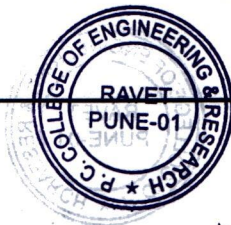
The Governing Body meeting was held on Friday, 8th January 2021 at 1:00 p.m. The venue was PCCOER-Board room. Following members were present for the meeting.

2. Approval to recommendation put up in CDC meeting-

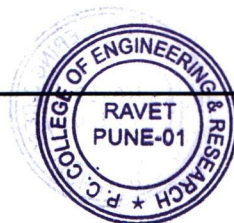
Principal put forth the recommendation of CDC for approval. All members review the recommendations put up in CDC meeting and approved the same.

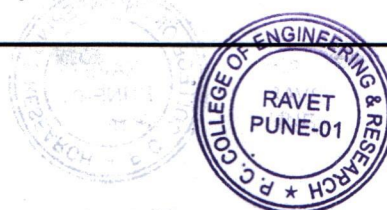

He also told that FE admission is in progress and the process of admission would be over by January end and depending upon the situations in view of the pandemic. Further all activities would be carried with maximum possible effectiveness.

4. Review of overall development –

Principal put forth information about overall development of College. He told about expenditure on laboratory equipment's till date, student and teaching and non-teaching staff Number on roll. He also gave information about results of all years. He also put forth the highlights of academics -

- a) Institute stood at 4th position with 66.8 % all clear result in SPPU.

- b) **Three university toppers** in Engg. Mathematics-I scoring 100/100 marks.
- c) Institute has 08 Ph.D. Holders and 36 faculties have done Ph.D. registrations.

Principal further put forth the highlights of training & placement activities –

- a) Probably the First Engineering College in India with 70% Placement in the First Batch.
- b) Two International Placements in First Batch with salary of 20 Lacs and 17 Lacs from 2018 batch.
- c) PCET's First International Placements to Ms. Shruti Subramaniam (PCCOE&R 2018 Batch) with package of 20 LPA. and Ms. Anjali Teke (PCCOE&R 2018 Batch) at Tokyo with package of 17 LPA.
- d) Placement percentage for 2019-20 Batch is 78.76 %.
- e) Highest salary offered for 2019-20 Batch is 28 LPA.
- f) Average Salary package is 3.57 LPA.
- g) Around 55% of PCET students got placed in IT Product or Core Companies.
- h) Ms.Sudeshna Uday singh Thakur student of 2020 Batch from Computer branch placed in product Development Company VMware with package 10 Lacs per year.
- i) Ms.Tejaswini Uttam Ghate student of 2020 Batch from Computer branch placed in product Development.

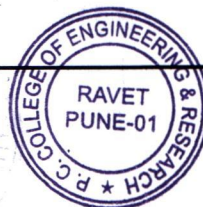
Principal also put forth the review of short term and long-term goals of the Institute and also told the achieved goals.

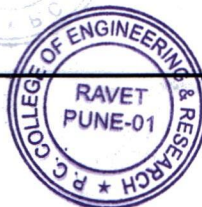
Principal put forth the requirement for the increase intake of Computer Engineering.

The GB members approved the requirements presented above and further directed to initiates the process. The GB congratulated Principal and HOD Computer for increased intake.

6. Review of NBA & NAAC preparation and requirements-

Principal told that all departments had satisfied pre-qualifier of NBA and College had submitted pre-qualifier on 9th July 2020 and NBA Self-Assessment Report (SAR) on 12th September 2020. Principal told about how the Institute and the team utilized the lock down period for preparation of NBA activities. He put forth the NBA activity calendar carried out during lock down period and told that all faculties had work regoursaly to fulfill all criteria of NBA, fully utilize the time for NBA preparation along with the academic activities. He told all

committee members that Institute is ready for NBA visit and told the expected dates of visit by NBA Committee.

Principal and all HODs further told the expected NBA SAR marks department wise and assured all committee members that Institute will definitely get NBA Accreditation with best grade.

Principal also told that, College is parallelly preparing for NAAC, committee for the same was also formed and initial review has been taken, Institute has plan to apply for NAAC very soon after NBA. He also explained the expected mark calculation of NAAC and assured all committee members that, Institute will definitely get NAAC accredited with good score. Principal told the committee that the Institute has been following outcome based education policy of NBA from the very beginning. He also told that experience of PCCoE NBA process has been very useful for this.

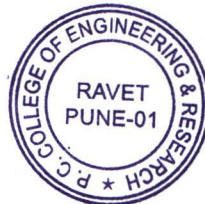

Prof.Rahul Mapari told that there is a need of seed funding for student start up. Principal told that we support start up from seed funding and we can further do the same as per the merit of proposal and its requirement. The Hon' secretary Shri.V.S.Kalbhor appreciated the Policy.
